



# Call for Nominations

## N. W. Jolly Medal

### Purpose

The Award is named in honour of Norman William Jolly (1882-1954) who made an outstanding contribution to development of professional forestry in Australia in the first half of the 20th Century.

The award of the N W Jolly Medal is the IFA/AFG's highest and most prestigious honour for outstanding service to forestry in Australia.

It recognises contributions from across the full scope of forestry and reflecting the diversity of significant contributions being made across a wide range of disciplines and forest management activities. In this context, forestry includes the sustainable management, development and use of forests for the diversity of goods and services that forest ecosystems provide, whether for public, private or commercial purposes, including education, research and development, forest policy and all types of forest land management

### Eligibility Criteria

- Any person, whether or not a member of the IFA/AFG may be nominated if they have made an outstanding contribution to forestry and the contribution supports achievement of the IFA/AFG's [objectives](#).
- In this context forestry includes the sustainable management, development and use of all forests for the manifold goods and services that forest ecosystems provide whether for public, private or commercial purposes, including - education, research and development, forest policy and all types of forest land management.
- A person deceased since the closing date of nominations for the previous award shall be eligible.

### Nominating Process

- Nominations for this medal close **Friday 6 August 2021**
- Nominations should be sent to [events@forestry.org.au](mailto:events@forestry.org.au)
- Any financial Voting Member of the IFA/AFG may nominate a person for the N.W. Jolly Medal. The nomination should be seconded by another financial Voting Member.
  - Nominations must be accompanied by a completed nomination form
  - a one-page citation in support of the nomination
  - Up to five pages of additional information detailing the nominee's work and publications may also be submitted.
- The nominator may seek information from the person being nominated however once a nomination is made, we ask that the nominators not discuss the nomination.
- All Confirmed nominations will be considered by the Jolly Medal Award Committee,
