FORESTRY AUSTRALIA VICTORIAN COMMITTEE REPORT - 2021

The Division was very active during 2021 despite limitations due to the COVID-19 pandemic. A Strategic Plan developed in December 2020 set objectives and strategies for the Committee for 2021-23. Those addressed in 2021 were mostly achieved, or significant progress made. Most are still relevant for 2022. I thank all Committee and Forestry Australia members for their active involvement in our activities. Key achievements in 2021:

1. Events

- Tree-via event for the International Day of Forests, March 2021
- East Gippsland Field Trip to connect with Traditional Owners and review 2019-20 bushfires. >40
 people attended.
- Next-Gen Technologies for Forest Management organised in partnership with the Royal Society of Victoria
- Victoria's Production Forests: a way forward, on the Victorian Forestry Plan for the transition out of native forest timber harvesting
- North East Victoria Forum and Field Trip to address long-term timber production and inspect plantation fire salvage and replanting > 50 people attended.
- Developments in Global Forest Restoration
- Proposed bi-monthly informal networking events were mostly postponed or cancelled due to COVID-19 restrictions. One event held in Warragul in December.

- Parliamentary Inquiry into Ecosystem Decline in Victoria
- Victorian Code of Forest Practice Review
- Submission to Major Events Review under the Regional Forest Agreements.
- Submission to Parks Victoria Land management strategy.

3. Other Initiatives

- Meeting with Timber Towns Victoria local governments with an interest in forest management to discuss forest management and their professional needs
- Ongoing discussions with the Gunaikurnai and Taungurung Traditional Owner Groups (in East Gippsland and north of Melbourne respectively) about how the IFA/AFG might support their aspirations for their country and their communities
- A shared electronic calendar of events with the 3 regional groups and Future Foresters Initiative to avoid clashes of dates
- An op-ed article in response to the Victorian Government's announcement following the Review of the Central West Forests based on the Victorian Environmental Assessment Council Recommendations;
- Information pitches to enable members to speak in a more informed way about forest management in Victoria
- Survey of lapsed members to understand reasons members resigned in 2019 and 2020
- Increased contact with regional treegrower groups to progress their aspirations
